



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

IMPLEMENTED MGT PRACTICES	<p>As part of the Due Dilligence, the company asks the potential investees companies to complete an ESG questionnaire developed by ESG_VC (www.esgvc.co.uk). This questionnaire is specialized for young or early-stage companies, and the results of the ESG questionnaire are included in the investment paper submitted for the Investment Approval Committee (IAC). The company then considers the ESG risks associated with the investee as part of the investment decision making process.</p> <p>Currently the company has investments in two companies in the alcohol industry. Both companies have the following practices in place to mitigate any risks to stakeholders:</p> <p>Boatyard Distillery: The Boatyard Distillery is fully compliant with the laws and regulations regarding the sale of alcohol in Northern Ireland. They have policies and practices in place to promote responsible alcohol consumption as well as an alcohol and drugs policy in their employee handbook. They ensure that they promote a healthy workplace and alieeveate pressure to drink at company parties. They send out emails promoting responsible drinking and taking a sensible approach to alcohol. For their tour groups, they offer numbers for taxi or boat for transport.</p> <p>Ireland Craft Beverages: Ireland Craft beverages complies with all regulations and laws related to the sale of alcohol, including drink-aware and non-advertising regulations in the local and export jurisdictions it operates.</p>
