Summary of Issue	LG2 is a brand experience agency based in Canada that has served clients operating in the Alcohol, Fossil Fuels (other), Mining, Cannabis related products (excluding recreational marijuana). Whole Life Insurance Products and Zoos, aquariums and animal parks industries over the last 5 years. Services to these clients have included branding, packaging, merchandising, web and advertising services; all that can be sold to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2023 revenue from clients in controversial industries represented the following % of the company's revenue: - 3.31% Clients operating in the Alcohol Industry; - 1.31% Clients operating in the Fossil Fuels industry; - 0.04% Clients operating in the Mining industry; - 0% Clients operating in the Cannabis related products industry; - 2.17% Clients operating in the Whole Life Insurance Products industry; - 0.44% Clients operating in the Zoos, aquariums and animal parks industries.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	LG2 partners with companies committed to responsible growth. However, the company believe that to maximize their impact, it's essential not to limit the work to top-tier clients alone. the company must also engage with companies in controversial industries that recognize their negative externalities and are genuinely committed to transitioning toward sustainable business models.
