



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Worker filed a complaint to the Employment Standards Branch of the Ministry of Labour Due to Disagreement over the Compensation Plan
SUMMARY OF ISSUE	<p>Brave Technology has had 1 complaint filed over the last 5 years.</p> <p>On November 20th, 2018, one of the start up team member was dismissed and the worker filed a claim with the Labour Tribunal in British Columbia claiming that he was owed salary for the time he had spent working with Brave without being paid a salary and overtime. The Company indicated that all of the start up team members had agreed to receive shares for their time spent instead of a salary during the start up period.</p>
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The complaint was settled by compensating the worker with an amount representing 5.5% of the company's revenue at the time.
IMPACT ON STAKEHOLDERS	Financial impact and loss of employment by former employee.
RESOLUTION	The three start up team members met and discussed a fair compensation package. The worker withdrew the claim from the Labour Tribunal and signed the settlement agreement.
IMPLEMENTED MGT PRACTICES	As a result of this issue Brave no longer accepts any volunteer or unpaid work of any sort. In addition, the Company took steps to compensate the other two start up team members in cash and shares for their contribution in a way that was acceptable to them.
