Summary of Issue	Robot Food Ltd is a branding & creative design company. The company is providing services to companies who are involved in the Alcohol industry. The company has served clients in this industry on an ongoing basis over the last 5 years. Between 2021-2023 the company has served clients in the Recreational cannabis industry. The collaboration ended in 2023 and Robot Food Ltd has formally committed to not provide its services to clients within this controversial industry. The company's services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	From the company's FY2023 annual revenue: • Clients operating in the Alcohol industry represented 21% • Clients operating in the Recreational marijuana industry represented 2%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Robot Food Ltd has strict adherence to local market legal guidance, sourcing of more sustainable print and packaging solutions and is non-targeting of minors. The company carries out due diligence during customer acquisition by spending time to investigate the client's business, processes and practices. The company would request that the clients supply them with codes of conduct and ethics along with their relevant CSR

	documentation for review.
	The company does not have a position on working with clients in sensitive industries, but choose to work with companies that have well defined code of ethics and conduct in place with regard to their general business practices and specifically their stance on responsible drinking. The company does not require their clients to sign their code of conduct but reviews their clients code of ethics and conduct and ensure it fits with the company's values as a business before initiating a working relationship.
