Summary of Issue	As a company based in New York, USA, Wine Enthusiast is a designer and developer of wine cellars and has grown into selling professional wine storage, furniture to glassware, gifts and accessories for casual drinkers and experienced collectors. Through their subsidiary Wine Express, Wine Enthusiast also earns a material amount of revenue from the sale of alcohol, through the sale of trademarked wines under their own brands, such as NFinity, Lattitude, BIE (Beverage Industry Enthusiast), Legacy, Vinoview, Vivid, Wine Importer Connection, Wine Star and Zenology.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 10% of Wine Enthusiast's revenue was earned from the sale of alcohol products.
Impact on Stakeholders	Alcohol may have a negative impact on the health and well-being of individuals and their communities.
Implemented Management Practices	The company complies with all of the regulations and laws related to the sale of alcohol in the jurisdictions where they operate. Wine Enthusiast have a legal team that specializes in alcohol and they follow all best practices which they update annually. Wine Enthusiast only sells wine online and has Point of Sale Policy for selling to underage individuals that is stated on the company's website (link available below) which conveys the message that Alcoholic beverages may be sold and delivered only to persons who are at least 21 years old and in placing the order, the person to whom delivery will be made is at least 21 years old. ID verified upon delivery is mandatory to have direct signature with ID check in person; deliveries are not completed without verification.
