

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Jelt Belt's products are assembled through a prison labor program administered by the Montana Correctional Enterprises Division.	
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	MCE is an organization operating under the Prison Industry Enhancement Certification Program (PIECP), which Congress created in 1979 to encourage states and units of local government to establish employment opportunities for offenders that approximate private-sector work opportunities. MCE employs 75 civilians and 500 incarcerated individuals.	
IMPACT ON STAKEHOLDER(S)	MCE provides skills and purpose to incarcerated individuals during their sentences. Participation in the program is voluntary, and employees earn a fair market wage to pay their victim restitution and court-ordered fines, and to save money for their release. PIECP programs reduce recidivism by 17%, decrease tax dollars spent on prison programs and continued criminal justice costs, and provide opportunities for American businesses to manufacture domestically.
