

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DESCRIPTION Significant supplier tour fatality

One of Inspired Adventures significant suppliers based in Southeast Asia had a vehicle accident three years SUMMARY OF ISSUE ago. One tour participant died. The vehicle accident was through no fault of the tour operator and did not occur on an Inspired Adventures tour. The significant supplier informed Inspired Adventures about this incident and introduced a range of stricter risk management procedures and policies.

SIZE/SCOPE OF ISSUE (e.g. \$, # of individuals affected)

This was a one time incident that affected one of Inspired Adventures significant suppliers. There was one fatality.

RESOLUTION Routine crisis management policies and procedures were activated during the incident. Inspired Adventures was informed out of courtesy, although it did not directly impact an Inspired tour. The tour operator reviewed their risk management policies and procedures and introduced an additional IMPLEMENTED MGT PRACTICES 50 page crisis management policy. Mandatory staff training on risk management and first aid certification

was already occurring, however, the tour operator increased this even further.
