ISSUE DATE	Jul-17
TOPIC	Three employees of Creative Energies tragically passed away in a small plane crash en route to visiting a potential solar project. A fourth person, the pilot and client, also perished.
SUMMARY OF ISSUE	In April 2015, 2 employees and 1 founder of Creative Energies (out of 18 employees at the time) tragically died in a plane crash while returning from an off-grid installation for a remote ranch in Idaho. The pilot was not an employee of the company and the plane was not owned by Creative Energies. This is the only instance where an event like this occurred at the company.
