



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

The majority of the company's projects are executed in collaboration with the local Native American community around Tulsa, Oklahoma, with a particular focus on improved community and economic development for these communities.</p> <p>Blue Star Integrative Studio is in the planning stages for design work on a tribal-run casino with one of their key tribal clients.</p> <p>B Lab considers the gambling industry as a controversial Issue, and as an additional requirement for B Corp Certification, requires Blue Star Integrative Studio to publicly disclose its affiliation with this industry.</p>

OTHER MANAGEMENT COMMENTS	Blue Star Integrative's (BSI) role is in the building design, and coordinating with mechanical and plumbing engineers to make sure the building is efficient and functions properly. BSI is not connected to gaming operations or any revenue sharing after completion.
RELATED INCIDENTS (YES/NO)	Casinos have been a useful economic development tool for tribes to lift their communities out of poverty. Most tribes realize they need to diversify their economies for true health and typically see them as part of a strategy for community health. Blue Star Integrative's belief is that B Corp should treat Native-owned and operated casinos differently than commercial developer-built casinos that are operated solely for commercial gain.
