Ingredient Marketing Class Action

Guayaki Sustainable Rainforest Products Inc. has settled a proposed class summary of issue action brought against it for allegedly concealing sugar in its tea-like yerba mate products by calling the ingredient "organic evaporated cane juice," according to documents filed Tuesday in California federal court.

RESOLUTION Removed the wording "Organic Evaporated Cane Juice" from packaging.

The claim in this lawsuit was not legitimate. An attorney claimed that a customer purchased Guayaki products in 2013 that were labeled with Organic Evaporated Cane Juice. This was not possible since we did not have any such ingredient listing during that time frame. 3 years prior we had used the term as it is a legitimate term used to this day by the organic fair-trade suppliers. Nonetheless we removed it to avoid any confusion. At all times our label fully disclosed the grams of sugar in every bottle.
