



## DISCLOSURE MATERIALS

<b>TOPIC</b>	Payslips not provided to show wage calculation and deductions
<b>SUMMARY OF ISSUE</b>	Payslips are not commonly used in China, and there is no standard reporting system. Smart Air at this time does not provide formally recognized payslips to its employees, but is working on a solution and will inform B Lab once it is in place. The government does however provide a system where each person's employment tax can be checked and monitored.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	All 6 employees at Smart Air
<b>IMPACT ON STAKEHOLDER(S)</b>	Employees do not see their tax payments and social benefit payments on a monthly basis.
<b>RESOLUTION</b>	Smart Air will assess what options are in place for providing payslips to its employees and work to provide payslips.
