| TOPIC | Company and its suppliers operate in Puna grasslands |
| SUMMARY OF ISSUE | Hilanderia Warmi operates in the Puna grasslands, an ecosystem in Argentina that is threatened by human activity. The company also sources its input materials, llama and sheep wool, from suppliers that operate in this ecosystem. |
| SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected) | "60% of Hilanderia Warmi's operations are located in the Puna region, and 90% of their raw materials are llama and sheep fibers produced in this region. Specifically, 75% of Hilanderia Warmi's material purchases are llama fibers, 15% of material purchases still come from sheep, and 10% are a cotton mix that is not produced in the Puna region." |
| IMPACT ON STAKEHOLDERS | Sheep farming in the region is a cause of environmental degradation, as overgrazing causes native grasses to be destroyed. Llamas, on the other hand, do not impact the root systems of grasses when grazing and thus are an environmentally preferred alternative. The company has a stated goal to have 100% of its material purchases come from llama fibers. |
| IMPLEMENTED MGT PRACTICES | Hilanderia Warmi has a mission to protect the Puna grasslands by creating a market for llama fibers through payment of above market prices. The company also provides capacity building to ensure their suppliers have access to adequate tools, such as shears. |

| OTHER MANAGEMENT COMMENTS | Our mission is to promote and position llama fiber at a national and international level, through design, communication and marketing, which will cause the market to attract more demand. Through this mission, we aim to positively impact the native pastures of the Puna ecosystem, which are currently being altered by sheep grazing in the region. |
