

## **DISCLOSURE MATERIALS**

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The company produces pet food using animal proteins, including beef liver, hoki fillets, arrowhead squid, green lipped mussels and salmon fins.

IMPLEMENTED MGT PRACTICES	Gourmate Pet Treat screens all their suppliers considering certifications, locality, owned/run by minority groups, environmental impact and practices compared to similar companies and the gold standard, workplace culture, and opportunities for the employees to develop/career opportunities. All their seafood is bought directly from the fisheries. Their suppliers are Southern Seafoods, Talleys and Mount Cook Alpine Salmon. Their suppliers own either the quota for the catch or the farms where the seafood is grown.  An essential criteria to be their supplier is to be owned and operated in New Zealand. This guarantees that Gourmate Pet Treat can be in touch with them, trace the origin of all products bought and guarantee transparency in the supply chain.
