Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	The company is a consulting firm that has had clients in the alcohol, bottled water, for-profit higher education, fossil fuel and debt collection industry. The nature of the company's services with clients in these industries has been related to consulting in economy and public policies, strategy and finance, marketing study as well as people development . All services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the Alcohol industry represented 6.04% in FY23. The revenue from clients in the Bottled Water industry represented 0.92% in FY23. The revenue from clients in the Debt Collection industry represented 2.96% in FY23. The revenue from clients in the For Profit Higher Education industry represented 1.04% in FY23. The revenue from clients in the Fossil Fuels industry represented 0.29% in FY23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has a Code of Ethics policy for its clients and a conflict check policy for new clients or projects that potentially require special attention.
