Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Marsh Creek Social Works is a consulting firm providing advisory services in relation to social impact. The company has had one client operating in the pharmaceutical industry which is deemed to be a controversial industry by B Lab. The nature of the company's services with clients in this industry has been related to executive advising, strategic planning support, background research support, operational planning, editorial support, bi-weekly 1-1 sessions, deliverable and content production, event support, implementation planning support, and regular communications. The services are only provided to the independent nonprofit foundation formed by the pharmaceutical company. Marsh does not work with the pharmaceutical company itself. All of Marsh's services can be provided to both controversial and as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2023, an estimated total of 57% of revenue were generated through the clients in the controversial industry as mentioned above.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Marsh Creek Social Works carefully considers each potential client to ensure it does not violate the organization's code of ethics, which states the following: "MCSW will not prioritize profit

	above values of social and environmental responsibility when choosing partners, working with clients, or operating MCSW". The company does not engage or service clients that does not align with the company's values, nor with ones that do not have a mission or objective that is focused on the social and environmental welfare of communities, employees, or environment. In considering a prospective client, Marsh does consider and analyze the at-present impact and results of a given organization, per the information available to them. For example, examining the annual reports, sustainability reports, and impact products produced by the potential clients. The focus of Marsh in working with clients is to help them extend and scale up positive social and environmental impact. Marsh's management team meets regularly to review its client work, including considering whether said work is at risk of violating the organization's code of ethics, or at any point shifts priorities and values counter to our own organizational values. Additionally, Marsh Creek Social Works also has an annual board meeting where the organization's programmatic work is reviewed including its social and community impact and alignment with the organization's values.
Management Comments	Marsh was introduced to its one pharmaceutical client through a partner, it was not work the organization sought out. Marsh does not intend to pursue any further work with pharmaceutical clients and will soon wrap up its engagement with its one current client in the space.
