TOPIC	Recalls due to excessive presence/ maximum residue level of the substance ethylene oxide, chlorpyrifos and gluten in the company's products
SUMMARY OF ISSUE	 KeyPharm has had five (5) recalls in the last five years due to due to the presence/maximum residue level for the substance chorpyrifos, ethylene oxide and gluten. Case 1- Physalis Patchoeli 10 ml (presence/ maximum residue level for the substance chorpyrifos has been exceed) - 15/12/2021 detection by FAVV by sample taken - lab result: 3,2 MG/KG. Percentage intake = 0.85%. This has no immediate pathogenic effects but may be carcinogenic in the long term with prolonged ingestion for children -18 years. Case 2 - Physalis Osteo Total (presence/ maximum residue level for the substance ethylene oxide has been exceed). On 12/08/2021, we received notification from the FASFC that the calcified Atlantic seaweed from Physalis Osteo total Lot 3275D was contaminated with ethylene oxide. Following analyses on the lot of calcified Atlantic seaweed imported from India, the maximum residue level for the compound ethylene oxide was found to be exceeded. Case 3 - Orca Ginseng Forte + Physalis Ginseng Forte + Physalis Organic C (presence/ maximum residue level for the substance ethylene oxide has been exceed) On September 24, 2021 at 19:14:19 we received notification from our subcontractor Laboratories WOLFS that their bamboo extract No. UO/BAD1504/06/20-21 imported from India, it was found that the maximum residue level for the substance ethylene oxide was exceeded. This lot was not added according to the agreed formulation, which was also not tested for this contaminant. Case 4 - Biotona Super Sprouts (presence/ maximum residue level for the substance ethylene oxide has been exceed): On 27/11/2020 We received notification from our supplier Petras Bio that the sesame seed from biotona supersprouts Lot 109755 is contaminated with ethylene oxide. Products were imported from India. It is allowed there. Batch was sold to europe even though it is not allowed in europe. Case 5 - Biotona supersweet 300 gram BIO lot 108464 : on 30/01/2020 we received a notification of FAVV : Undeclar

No injuries/illness were reported.

IMPACT ON STAKEHOLDERS	Ethylene oxide & Chlorpyrifos has no immediate pathogenic effects but may be carcinogenic in the long term with prolonged ingestion. No injuries/illness were reported from the recall incidents.
RESOLUTION	 Recall notification to the company's customers and their end customers. Case 1 - Physalis Patchoeli 10 ml. Recall notification to customers and end consumers. Case 2 - Physalis Osteo Total. Recall notification to customers and end consumers. Case 3 - Orca Ginseng Forte + Physalis Ginseng Forte + Physalis Organic C. Recall notification to customers and end consumers. Case 4 - Biotona Super Sprouts. Recall notification to customers and end consumers. Case 5 - Biotona supersweet 300 gram. End products were taken off the shelves by the company's customers, before being available for the final customers.
IMPLEMENTED MGT PRACTICES	The company has blocked all end products involved and tracked all customers. It has set-up a meeting of crisis team, investigated the problem, including the dangers the recall posed to end-consumers. The measures were extended to evaluate if the excessive presence/ maximum residue level of the substance ethylene oxide and chlorpyrifos also extended to other company's products. The measures consisted of checking the report limits from the Federal Agency Food Safety, informing the Belgium Food Safety Agency Belgium (FAVV) with the official form, the OCI's (audit company food safety), the BIO control body, customers. Furthermore, the company has adjusted and updated its HACCP (hazard analysis and critical points) plan, analysis plan and food fraude plan in the company's Food Safety System to avoid further recurrence. Lastly, a complaint was sent to the supplier/subcontractor to determine the root cause of the problem and assure preventive measures were implemented.
RELATED INCIDENTS	The company has not experienced other incidents rather than the ones reported.
