OTHER MANAGEMENT COMMENTS	<p>We are a farmer-direct beverage company that works in the agriculture of coffee and tea. Coffee in most forms is grown principally in coffee fields which normally are shade grown and grown with other plants and trees. Many of our farmers grow other crops in conjunction with their coffee as well as planting trees and other foliage for windbreaks, shade and protection of the crops. Tea is grown on tea plantations in hedge rows. Both crops are no-till crops that last years in their life cycle.</p> <p>Coffee is a perennial culture, planted and re-planted approximately every 25 years. Coffee is planted normally in conjunction with other plantings that require shade and is subject to a farm plan for the best use of the farm based on topography and other environmental considerations. Due to this fact, coffee is considered a monoculture.</p> <p>The production of coffee by our suppliers does not impact biodiversity and in some instances the production of coffee will stimulate the planting of further vegetation to stimulate biodiversity where other monoculture or grazing occurred before.</p>
