- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ТОРІС	Company is legally required by the FDA to carry out animal testing on some of their products.
SUMMARY OF ISSUE	Nuliv Science USA Inc. is a science based ingredients company located in Brea, California. The company sells ingredients and products based on patented ingredients, including mushrooms, and botanicals. The company claims that all animal testing related to their products is legally required by the FDA in order to obtain Generally Recognised as Safe (GRAS) status. This includes individual cell testing and animal testing.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	According to the company, 3 of their 14 active ingredients underwent animal testing. They represent around 35% of the company's gross revenue and 20% of sales growth per year, on average.
IMPACT ON STAKEHOLDERS	Animal testing and experimentation is widely used to develop new products and to test the safety of other products. Many of these experiments can cause pain to the animals involved or reduce their quality of life in other ways.
IMPLEMENTED MGT PRACTICES	According to the company, there are no alternatives avavilable as the FDA explicitly demands a 90-day acute toxicity study on rats; The European Food Safety Agency requires a 90-day and, sometimes, a 180-day test depending on the existing toxicity evidence of a food compound. All third-party laboratory must follow Good Laboratory Practices (GLP) and follow strict protocols for animal handling as outlined by OECD guidelines.
