Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	A shareholder and former employee of one of BearingPoint's subsidiaries claimed against BearingPoint for (i) unfair dismissal, (ii) indemnity for not honoring the shareholders agreement; and for (iii) consulting fees from a consultancy contract with Bearingpoint.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total value of the litigation was approximately € 1,115,000, representing less than 1% of the total revenues for the fiscal year 2023.
Impact on Stakeholders	A shareholder and former employee were affected.
Resolution	The cases related to the first two claims were ruled against the company. The case related to the third claim is pending resolution
Management Practices	The company has reviewed and documented the cases for the legal, human resources, and risk teams to analyze.
Management Comments	The company has analyzed the case for learning from future situations. No particular actions were taken.

Summary of Issue	<p>BearingPoint is an independent management and technology consultancy with European roots and a global reach. The company operates three business units: Consulting, Products and Capital. Consulting covers the advisory business with a clear focus on selected business areas. Products provide IP-driven digital assets and managed services for business-critical processes. Capital delivers M&A and transaction services.</p> <p>Over the last 5 years, the company has served clients operating in industries identified by B Lab as controversial, including: Pharmaceuticals, Defense, Offensive Firearms/weapons industry, Fossil Fuels, Nuclear Power or Hazardous Materials, Gambling and the Prison industry.</p> <p>As an independent consulting firm, services can be sold to both clients in industries considered by B Lab as controversial as well as non-controversial industries.</p> <p>The company is committed to B Lab's current standards and is considering committing to future standards related to clients in the Defense and Offensive Firearms//Weapons industries once they become available.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>In FY2023 revenue derived from clients in controversial industries represented the following % of the company's revenue:</p> <ul style="list-style-type: none">• 2,4% from clients operating in the Pharmaceuticals industry.• 1,3% from clients operating in the Defense industry.• 1,2% from clients operating in the Offensive firearms/weapons industry.• 0.89% from clients operating in the Fossil Fuels (coal, oil sands)• 0% from clients operating in the Gambling industry. <p>Engagement with this industry was through a one-off engagement in FY2021.</p>

Impact on Stakeholders	<p>Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.</p> <p>B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.</p>
Implemented Management Practices	<p>Bearing Point carries out a client background check, a credit check, a conflict of interest check and in cases of clients being outside of their "home markets" (markets where Bearing Point does not have office locations), they also conduct a legal and location check.</p> <p>The company's Risk & Quality Management area reviews and approves offers prior to submitting an offer proposal to their clients.</p>
Management Comments	<p>BearingPoint has processes in place to carefully choose projects in the named industries. As an independent consulting company, BearingPoint believes that business growth is not in itself unhealthy and that engaging with controversial industries is necessary and can have a positive impact to stakeholders and beyond.</p>
