



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Recall of products due to mislabelling
SUMMARY OF ISSUE	Between 2015 and 2016, Michel et Augustin issued four separate recalls for products that were mislabelled.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The total accumulative amount from the recalls accounted for 5.5% of annual revenue.
IMPACT ON STAKEHOLDER(S)	There were no customer complaints received in relation to the recalls.
IMPLEMENTED MGT PRACTICES	The company implemented several changes after the incidences including increasing employee training, machine replacements, investments in machine accessories and reinforced controls. They also conducted audits of suppliers and enlisted more detailed questioning regarding allergens present in raw materials. The company also added additional wording to their product labels to warn against potential allergens. They also implemented a new labelling policy for cross-contamination of products containing at least one nut : 'possible traces of other nuts'.
