Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Company serves clients in Controversial Industries
Summary of Issue	Nouvellebox Ltd is a company that provides a platform for jewelry brands to show and sell their work to the global market. The jewelry industry has a higher risk of encountering social and environmental issues in their supply chains, as the raw materials (precious metals and gemstones) are often sourced from conflict-affected areas. Specifically, money laundering, human rights violations, and contributions that fund armed conflict (directly or indirectly) are material risks present in the industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue has been from clients in the jewelry industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has a Code of Conduct to define the standards that NouvelleBox expects from suppliers throughout their supply chain regarding workplace ethics, environmental responsibility, animal welfare, business integrity and monitoring. This code of conduct adheres to recommendations from: • The United Nations Guiding Principles on Business and Human Rights • The Internal Labour Organisation (ILO) conventions • The Ethical Trading Initiative (ETI) base code • The Living Wage Foundation Considering the company's involvement with the jewelry industry, the NouvelleBox recognizes that the mining industry

	poses many significant environmental and social risks and impacts. They, therefore, ask the jewelers and makers they work with to pay close attention to the ethics and standards of any mines in their supply chains. For any large mines within the company client's supply chains, NouvelleBox demands: - The company's mine sites have achieved at least IRMA 50 Certification or Fairmined (ARM) Certification or equivalent credible certifications, and are actively working towards IRMA 100 standards. - Companies that are engaged in mining and purchase from other mine sites must have formalized policies and ongoing monitoring to manage the environmental and social risks of the mining industry in their direct supply chain using the IRMA or Fairmined standards, including for example, policies and practices encouraging supplier mining companies to begin using the IRMA self-assessment, using such assessments to identify and encourage needs for improvement, and progressing towards audited and IRMA certified mine sites over time. As part of the monitoring of the company's Code of Conduct, suppliers must by appointment provide open access at reasonable times to all facilities by NouvelleBox employees or any third party representative engaged to work on their behalf for the purpose of auditing. Where there is a breach of this Code we will work with suppliers to agree a reasonable timeline to make improvements to ensure ongoing compliance.
