Description of Positive Environmental Product / Service Impact

20 billion tampons and pads are dumped into landfill each year globally and it takes the average menstrual pad 500 years to biodegrade. By providing reusable period underwear, Modibodi offers an alternative that reduces the reliance on disposable menstrual products and reduces waste going to landfill. Modibodi pants have a long service life with testing showing they perform for more than 100 washes which reduces the overall environmental impact of production. In the use-phase, we recommend Modibodi pants to be washed on a cold cycle and air dried - which reduces use-phase energy consumption. In the production phase, we ensure our fibres grown on agricultural lands are certified organic or FSC certified to support the responsible production of textile fibres. We have committed to transitioning our materials toward our preferred and better standard which prioritises biodegradable, recycled, recyclable and renewable materials. Switching to reusable underpants can have a huge impact on reducing carbon emissions. One person's yearly use of disposable tampons produces 8.2kg of CO2 emissions or for a pad user 16.8kg of CO2 emissions. We undertook a lifecycle assessment to compare the absorbent gussets in our underpants to disposable single use products over four years to give the most like for like carbon emissions comparison. The results showed that Modibodi gussets create significantly fewer carbon emissions with a Heavy-Overnight gusset and a light-moderate gusset creating 60% and 70% fewer carbon emissions than equivalent pads and tampons.* *Based on 8 pairs of classic bikini Modibodi merino gussets over four years compared to equivalent tampons and pads.

We undertook a Lifecycle Assessment of our products in comparison to tampons and pads. The study found that: The carbon footprint of the Light to Moderate (LM) Gusset is 57-58% lower than tampons and pads when used for 1-2 years, and 78% lower when used for 4 years. The carbon footprint of the Heavy Overnight (HO) Gusset is 27% lower than tampons when used for 1-2 years, and 62% lower when used for 4 years. Similarly, its carbon footprint is 39% lower than sanitary pads when used for 1-2 years, and 68% lower when used for 4 years.

Toxin / Pollution Reduction Overview

Disposable pads and tampons cause solid waste pollution as well as microplastic pollution in both land and water. As an alternative, our reusable products are designed to last 2-3 years and more than 100 washes. All our products are Standard 100 by Oeko-Tex® certified as free from harmful substances to human health including allergens and carcinogens. Our certificates cover Class 1 for baby products, Class 2 recycled products, organic products and other fibres. In addition, our fabrics treatments are BlueSign approved and our garments are PFAS free from a group of 4700+ industrial chemicals. Our current cardboard sleeve product packaging and boxes are Forests Stewardship Council (FSC) certified and made from a minimum of 75% recycled paper (max 10% FSC paper, water and starch) and can be recycled after use. To deliver our products we use compostable ComPOST parcel bags, which are made from GMO-free renewable plants and compostable resin – avoiding 60% CO2 emissions compared to a traditional plastic parcel bag. The Better Packaging company claims its production is partly neutral in its climate positive scheme, since it offsets carbon emissions by 120%. In 2021, we partnered with Canopy for the Pack4Good campaign to source Next Generation packaging alternatives. In 2022, we will implement our Canopy Package4Good policy in the procurement of paper products and man-made cellulose fabrics, including a focus on the redesign and reuse of cardboard shipping boxes. We are transitioning from bamboo viscose to bamboo lyocell to reduce chemical and energy use at the production stage. In 2021 we launched the first biodegradable period underwear pant to market. No other company has achieved this. This world first innovation was created using a blend of TENCEL™ and Merino wool, scientifically proven to break down into nontoxic substances at the end of their usable life. The underwear is 97% biodegradable. The waist and leg elastic contain a small amount (less than 3% of the total garment) of elastane that is not biodegradable. The tiny amount of elastane will eventually degrade however it will take a longer time than the rest of the garment. The garment will start to biodegrade in active soil within weeks. Our Biodegradable underwear have been tested at Royal Melbourne Institute of Technology (RMIT) using the ISO 11721-1:2001, Biodegradable Test. RMIT is a globally recognized institute that performs research and testing through the School of Fashion and Textiles.

By the end of 2022 we plan to have traceability across 50% of our suppliers and we will continue to work toward greater transparency so that we are able to source from businesses and farms that excel in positive social and environmental impacts. Disposable pads and tampons cause solid waste pollution as well as microplastic pollution in both land and water. As an alternative, our reusable products are designed to last 2-3 years and more than 100 washes. All our products are Standard 100 by Oeko-Tex® certified as free from harmful substances to human health including allergens and carcinogens. Our certificates cover Class 1 for baby products, Class 2 recycled products, organic products and other fibres. In addition, our fabrics treatments are BlueSign approved and our garments are PFAS free from a group of 4700+ industrial chemicals. Our current cardboard sleeve product packaging and boxes are Forests Stewardship Council (FSC) certified and made from a minimum of 75% recycled paper (max 10% FSC paper, water and starch) and can be recycled after use. To deliver our products we use compostable ComPOST parcel bags, which are made from GMO-free renewable plants and compostable resin – avoiding 60% CO2 emissions compared to a traditional plastic parcel bag. The Better Packaging company claims its production is partly neutral in its climate positive scheme, since it offsets carbon emissions by 120%. In 2021, we partnered with Canopy for the Pack4Good campaign to source Next Generation packaging alternatives. In 2022, we will implement our Canopy Package4Good policy in the procurement of paper products and man-made cellulose fabrics, including a focus on the redesign and reuse of cardboard shipping boxes. We are transitioning from bamboo viscose to bamboo lyocell to reduce chemical and energy use at the production stage. In 2021 we launched the first biodegradable period underwear pant to market. No other company has achieved this. This world first innovation was created using a blend of TENCEL™ and Merino wool, scientifically proven to break down into nontoxic substances at the end of their usable life. The underwear is 97% biodegradable. The waist and leg elastic contain a small amount (less than 3% of the total garment) of elastane that is not biodegradable. The tiny amount of elastane will eventually degrade however it will take a longer time than the rest of the garment. The garment will start to biodegrade in active soil within weeks. Our Biodegradable underwear have been tested at Royal Melbourne Institute of Technology (RMIT) using the ISO 11721-1:2001, Biodegradable Test. RMIT is a globally recognized institute that performs research and testing through the School of Fashion and Textiles.

We are moving 90% of our main fibres to Preferred or Better Fibres by the end 2022. Preferred and Better fibres are those that have lower energy and emissions requirements and are biodegradable at end-of-life. We use Merino wool in our supply chain. The farms we source from farms in Australia that abide by Australia's strict animal welfare laws. We only source wool that is grown by sheep that are non-mulesed. We have begun the process of tracing our wool back to raw material production so we can have full transparency across the supply chain. Two of the farms we source from practice regenerative agriculture. We are moving our bamboo viscose to bamboo lyocell, which has lower energy and processing requirements as well as FSC-certification. Our cotton is certified organic, reducing the use of pesticides and herbicides in our supply chain. All packaging is FSC-certified and we have committed to Canopy's Package4Good campaign to ensure the products we source do not impact ancient and endangered forests. We are currently on a journey to map our suppliers from the farm to our cut-and-sew facilities, a process which will continue throughout 2022 and 2023. We have set high environmental and social standards to provide confidence in our products throughout their life cycle. While many brands do not trace their supply chain back to fibre creation we feel this is important for transparency. We work with three cut and sew factories in China. These factories are audited annually for social and labour compliance with both BSCI and the Higg Index. If any issues arise, we help in the development of a corrective action plan. All garment workers in our cut and sew factories earn at least the minimum wage and in 2022, we will collaborate with our suppliers to develop a roadmap toward increasing and ring fencing Tier 1 garment worker wages to meet a Living Wage. A Living Wage should be earned in a standard work week (of up to 48 hours) by a worker, and be sufficient to afford a decent standard of living for the worker and their family. Elements of a decent standard of living include food, housing, healthcare, clothing, education, transportation, energy and water. It also includes some money that can be put aside for unexpected events. We will transparently share our Tier 1 supplier list during 2023. All fabric waste generated by our cut and sew suppliers is resold to a fabric recycler.
