Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Others - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Agencia de Aduanas Felipe Serrano Solar (FSS) is a customs agency, Authorized Economic Operator in Chile, that has had clients operating in the Mining, Pharmaceuticals and Offensive Firearms/Weapons industry. The service provided to these clients has been the legal import of goods into the country; an activity which is regulated by the National Customs Service. The services offered to these clients can be offered to both clients in controversial as well as non-controversial industries. The company has discontinued working with clients operating in the Offensive Firearms/Weapons Industry and has committed to not take up work from clients in this industry in the future.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY 2023, 2% of the company's revenue was from clients operating in the Mining industry. In FY 2023 clients operating in the Pharmaceutical industry represented 2.40% of the company's revenue. In FY 2023, revenue from clients operating in the Offensive Weapons/Firearms industry represented 0.23%. The company no longer works with clients in this industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	FSS follows strict protocols of the Chilean National Customs Service (Servicio Nacional de Aduanas) and customs regulations in order to review and control all of the necessary documentation to import goods for their clients.

	The company is an Authorized Economic Operator (AEO) (see link below) that has the objective to strengthen the security of the international supply chain by certifying that affiliated companies comply with a standard that guarantees the security of their commercial processes and operations. This process therefore requires from FSS to request a series of documents to avoid working with companies that may be involved in smuggling illegal goods or money laundering. Under the company's AEO certification policy, FSS only works with companies that provide them with the requested documentation to prove that they are a duly registered company in the country, that the merchandise they import or export is allowed and that the operation is legal by paying their respective taxes. FSS has committed to no longer work with clients operating in the Offensive Firearms/Weapons Industry.
Report	AEO Certification
