Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	2024-2025
Topic	Arbitration related to Consumer Protection
Summary of Issue	Between 2024 and 2025, the company was involved in 37 arbitration cases related to Consumer Protection, 35 of which specifically concerned the website's compliance with the Americans with Disabilities Act (ADA). The company was also involved in two additional cases related to false advertising and labeling non-compliance.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total value of the arbitration cases represents less than 1% of the company's annual revenue for 2024.
Impact on Stakeholder(s)	Website's compliance with the Americans with Disabilities Act (ADA): The main potential negative impact to consumers is that individuals with disabilities may have been denied equal access to the company's website, limiting their ability to use its services or obtain information. False advertising and labeling non-compliance: The main potential negative impact is misleading product information, which can lead to uninformed consumer purchasing decisions and potential health or dietary risks.
Resolution	All the cases were settled with payment.
Implemented Management Practices	In early 2025, Country Life hired a 3rd party to upgrade its website to be ADA-compliant.
Management Comments	<i>"As of January 1, 2025, the company is fully ADA compliant after engaging a third-party firm to audit and upgrade the site"</i>
