Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	ICM opleidingen & trainingen offers management consultancy and training and has served clients operating in the Gambling, Defense, Fossil Fuel (other than coal, oil sands), Nuclear Power or Hazardous Materials, Pharmaceuticals and Charity Lottery industries over the last 5 years. Services to these clients have included training on personal leadership, personal effectiveness, performance reviews, giving feedback, change management, formulating SMART goals, decision-making, analytical skills, team building, agile working, tactical skills for trainers, among others; all services that can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients operating in the Gambling industry represented 0.06% of the company's current FY2023 revenue. Revenue from clients in the Defense industry was through a one-off engagement in FY2020 representing 0.15% of the company's revenue. The company no longer works with clients in this industry. Clients operating in the Fossil Fuel (other) industry represented 1.05% of the company's FY2023 revenue. Clients operating in the Nuclear Power or Hazardous Materials industry represented 0.16% of the company's FY2021 revenue, they are longer engaged with this industry. Clients operating in the Pharmaceutical industry represented 0.08% of the company's FY2023 revenue. Clients operating in the Charity Lottery industry represented 0.09% of the company's FY2023 revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.

	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not currently have a position on working with clients in controversial industries and evaluates whether to collaborate with a potential client prior to engagement. This evaluation includes whether the organization causes harm to society or the environment. The company does not wish to collaborate with a tobacco producer. ICM does not have a due diligence process in place to ensure that the services provided by the company are not used to cause harm on society or the environment.
Management Comments	ICM aims to make a positive impact on all its clients. We encourage our clients to bring out the best in themselves and work on their sense of purpose, both in their current jobs and in the future. In our programs, we foster awareness and promote personal leadership. This way, we aim to influence organizations and their employees to make more impactful choices in the future.
