



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company operates an animal farm and has direct control over the treatment of animals in its care.
SUMMARY OF ISSUE	100% grassfed, 100% pasture-raised. They are also Land to Market Verified by the Savory Institute.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	777 Bison Ranch provided us with all of their harvest-ready bison last fall (annual harvest). These animals represented 80% of our revenue. There were 280 bison harvested last fall/winter. 1800 to 2000 bison are normal head counts for 777 Bison.
IMPACT ON STAKEHOLDERS	95% of the industry operates through Confined Animal Feeding Operations (CAFO's). These confinement operations can have severe problems with diseases and violate some basic humane treatment fundamentals. They also feed their bison with grain, soy and corn, which is not healthy for the animal. Our bison are never confined, and always fed 100% grass which is appropriate for their guy biome. We are American Grassfed Association certified.
IMPLEMENTED MGT PRACTICES	The company believes in and promote GAP 4 standards. They also call out that their supply of bison is exclusively sourced from 777 Bison Ranch.
