Issue Date	March 2022, and April 2023
Topic	Litigation/ Arbitration related to labor issues
Summary of Issue	The company has had 2 labor litigation cases over the last 5 years in relation to improper payment due to miscalculations in relation to unhealthy work and overtime. 1 case in March, 2022 in relation to an occasional free-lancer, later in probation period, that has been settled, and they have 1 case in April, 2023 filled by an employee, that is still pending.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	2 cases in total, closed case represented <1% of the company's revenue and the pending case represents 4.9% of the company's annual revenue.
Impact on Stakeholders	1 contractor and 1 former employee.
Resolution	1 case has been closed and payment has been made and the second case is still pending.
Implemented Management Practices	In order to prevent such cases from recurring in the future, Arco Residuos has improved their employee time records, PPE delivery records and created an employee manual which is constantly reviewed and improved. In addition the company has improved their third-party hiring process and overall employee/contractor onboarding process, clarifying their values and culture. For third parties who work regularly at ARCO (30 or 40 hours per week), company implemented a contract, and a work performance report, for clarity in payments. For third parties who freelance on an occasional basis, company implemented a contract with detailed activities. Payments are made on the same day, and receipts are signed. Furthermore the company has joined a union to ensure clarity of duties of the employee and employer and carry out climate research to understand dissatisfaction of employees.
