Topic	Company sells products containing CBD
Summary of Issue	Unrooted Drinks is a Beverage Manufacturer based in the UK that produces and sells a CBD health shot.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	16% of the company's revenue is derived from their CBD product.
Impact on Stakeholders	Cannabis-related products may be subject to controversy in certain jurisdictions because of its current legal status as regulators react to the increase in demand for CBD-related products. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	Happy Curations Limited (t/a Unrooted Drinks) complies with all local regulations and industry best practices, including working with reputable suppliers, conducting lab tests on its products and including any required warnings and disclosures on its labels. The company carries out periodic batch testing of its CBD products to ensure the CBD content is accurate. They also comply with all labeling regulations informing consumers that the product is not suitable for children, pregnant or breastfeeding women and those taking medication as well as the daily recommended dosage (3 shots).
Management Comments	CBD has wide market acceptance as demonstrated by sales of our CBD product in mainstream retailers such as Ocado and Holland & Barrett, in addition to the 'novel foods' acceptance and regulation of the ingredient. Furthermore, CBD is widely known and considered to have substantial health benefits, and is positioned as such in leading UK health foods retailers. Any potential concerns about the safety of CBD have been satisfied over the past 3-5 years, and is an outdated view on this ingredient which neither the market nor Unrooted Drinks and our stakeholders currently share.
