Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a Controlled Environment Agriculture (CEA) grower, Harvest London operates in an industry that is recognised as being energy intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of Harvest London's revenue from the previous fiscal year came from the sale of products grown using CEA.
IMPACT ON STAKEHOLDERS	"Controlled Environment Agriculture (CEA) can be energy and carbon intensive due to the potential use of artificial lighting, heating, cooling, and dehumidification to create the ideal environment for plant growth and photosynthesis.
	Environmental impact is dependent on the energy sources used."
IMPLEMENTED MGT PRACTICES	"Harvest London's electricity is provided by a 100% renewable electricity provider (Octopus). As such it produces no carbon emissions from running the farm (it does not have gas to its unit). In addition, it also uses zero carbon transport to deliver produce to customers. An additional step, which isn't possible in the company's current premises, but will be in the next, is to have on-site renewable energy generation, and to use plant waste in an anaerobic digestor to create heat and power for the farm.
	The company does not have specific energy/carbon reduction targets at the moment, as the current farm runs on 100% renewable energy, so there is no scope there, and overall its carbon footprint is low (and minimised by using zero carbon transport, re-usable packaging etc.) It will develop its own targets in 2022, as it hopes to begin construction on a new, bigger farm, soon.
	In addition to the practices outlined above, Harvest London conducts delivery in reusable containers (that are dropped off with the customer and then collected). The company has calculated the carbon saving of its current products compared to the alternatives imported from the Middle East, and estimate a saving of around 8,000kg of CO2 equivalent per tonne of produce is achievable. The company has modelled the carbon impact of future, larger farms, and looked at potential carbon abatement of between around 200,000-400,000kgCO2e for a 10,000 square meter farm. This will be part of its reporting in future."
