Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	MITON, S.L. is a marketing company that has had clients operating in the alcohol and pharmaceutical industries over the last 5 years. The nature of the company's services with clients in these industries has been related to campaigns and promotions, all services that can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients operating in the Alcohol industry represented 3% in FY23- 24. The revenue from clients operating in the Pharmaceuticals industry represented 13% in FY23- 24.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact on stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue, and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have any positions on working with sensitive industries. The company monitors its clients' activities and verifies their commitment to sustainability by checking on the client's website for public information or requesting more information from their client. As their clients have well-known products that have no negative implications, the company does not do further checks. The company complies with their clients' code of conduct and their clients receive their code of conduct, but does not require their clients to sign and comply with their code of conduct.
