

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Evergreen Health Solutions share anonymised user data with third parties. The company is recognised as a data controller under UK law. Company operates an app that gathers data on personal health and DNA through the creation of a customer account. Company asks customers to share their anonymised data to access their wellness score. Customers are also able to become 'data donors'.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of consumer data that gave consent had their data shared with a third party.
IMPACT ON STAKEHOLDER(S)	Users may object to the sharing of data with third parties outside of Evergreen Health, in that case the user may choose to remove their consent to share their data outside of those services necessary for the functioning of the Evergreen Health app.
IMPLEMENTED MGT PRACTICES	The data that is entered, transmitted and stored is encrypted to prevent any unauthorised use of the data. All of this information is outlined the company's terms of use policy available here: https://www.evergreen-life.co.uk/terms/website-terms-of-use which outlines the types of third parties that they share user data with including the NHS, health organisations, and academic and non-profit research institutions. In the case where the company shares data, they ensure it is in accordance with their Privacy Policy and Data Processing and Retention Policies, and is subject to adequate and appropriate security measures, such as pseudonymisation (taking steps so you cannot be directly identified from the data shared). Wherever possible data will be made anonymous prior to sharing.
	Evergreen Life has a direct relationship with users of its' app which is governed by the Evergreen Life terms of use and privacy policy. Users consent to their data being processed by Evergreen as Data Controller in accordance with these terms. For any sharing of identifiable or pseudonymised data with third parties, additional explicit consent is obtained from users. Users can withdraw their consent at any time in the Evergreen Life app where they can also view and manage their sharing consent history.
