TOPIC	Sale of CBD Products
SUMMARY OF ISSUE	Daye is a retailer of menstrual care products that earns a material amount of revenue from the sale of products containing CBD oil. CBD oils are derived from industrial hemp, a cannabis related product.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 59% of Daye's revenue was earned from the sale of products containing CBD oil.
IMPACT ON STAKEHOLDERS	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
IMPLEMENTED MGT PRACTICES	Daye is compliant with all regulations related to the sale and distribution of cannabis-derived products. The company has an exclusive agreement with a commercial partner that has developed a proprietary technology to completely remove THC from the hemp plant and deliver CBD oil with 0.00% THC.  Further, all regulatory bodies require that no THC is present in CBD oil. In order to ensure that the company's products do not contain THC, every batch of CBD oil supplied is THC-free certified. The certificate is issued from a calibrated machine and its calibration status is continuously verified as part of ongoing supplier evaluations. Samples from CBD batches are also tested at random with third-party laboratories. The company is not involved in the sale of medical or recreational marijuana products.

MANAGEMENT COMMENTS	Daye exclusively purchases CBD that is derived from industrial-hemp. Unlike marijuana, hemp has been excluded from the United States' Controlled Substances Act with the introduction of the 2018 Farm Bill. The bill defines hemp as the cannabis plant that cannot contain more than 0.3 percent of THC. According to the new act, hemp can be commercially grown and manufactured into CBD products for sale to the public. Industrial-hemp derrived CBD is also legal in the EU, UK, Japan, China and other regions.

DISCLOSURE QUESTIONNAIRE CATEGORY	Animal Testing
TOPIC	Daye produces and sells tampons that are legally required to be tested on animals for sale in the US in order to ensure their long-term safety in human use.
SUMMARY OF ISSUE	Tampons are required to be tested on animals to be commercialized in the US, per FDA guidelines, given that tampons are considered medical devices in the country. Daye conducted a one-off animal test and made a public statement on its website detailing how it was conducted and why it was required. The company attempted to use alternative methods but was informed that animal testing is required by law.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	87% of the company's products have undergone a single one-off animal test.
IMPACT ON STAKEHOLDERS	Animal experiments are widely used in food & drug research to evaluate the quality, safety and efficacy of new products. Many of these experiments can result in suffering to the animals involved or reduce their quality of life in other ways.
IMPLEMENTED MGT PRACTICES	Daye outsourced animal testing. Daye chose animal testing companies that follow best practices, cover international standards, and are committed to animal welfare. The company selected by Daye to conduct its animal testing and animal studies was held to ISO10993 standards (https://www.iso.org/standard/68936.html), which include clear guidelines for the humane treatment of lab animals (https://journal.emwa.org/medical-devices/does-standardisation-improve-animal-testing-of-medical-devices/).
	The company's mechanisms to foster best practices include active participation in numerous national and international scientific meetings to ensure Daye obtains and imparts knowledge about best practices, and the establishment of an Ethics Committee or Institutional Animal Care and Use Committee. These committees are responsible for meeting on a regular basis to establish guidelines to identify and harmonize best practices used in testing sites. Regular site visits are also conducted by the senior members of the Animal Welfare and Training group to identify areas of excellence and facilitate sharing of information with others, and the establishment of a network of Animal Welfare Specialists for all business units worldwide. These individuals are appointed by Daye's CEO and work with the Department of Animal Welfare and Training on a regular basis.

MANAGEMENT COMMENTS	Daye addresses stakeholder concerns by openly speaking about the requirement of such testing on its products, explaining why they have had to do it and what they are doing to prevent this from being a requirement in the future. The company started working with a company called Printivo to try and develop an artificial vaginal canal and mucosa—this is a long-term project, which is still underway. They are in the final stages of developing an artificial vaginal fluid with Prof. Simon Gaisford from University College London. Daye has made the decision to open-source the artificial vaginal canal and vaginal fluid, so future female health companies can have access to them for their own product trials and not have to conduct animal testing.
