



DISCLOSURE MATERIALS

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Ev Dot Energy is a software company that sources renewable energy to charge electric vehicles. The company shares user charging data (time and volume of electricity consumed) with their utility and / or other energy and charging related partners. This customer is informed of why their data is being shared, and they have explicit consent of the customer. Data is typically shared when ev.energy wants to deliver a joint service in partnership with another third party, for example to deliver an energy tariff in partnership with the customers energy retailer, or to deliver services to the local distribution utility or to access a rapid charging infrastructure to charge their electric vehicle.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company shares approximately 60% of their user data with third party utility provider.
IMPACT ON STAKEHOLDER(S)	Users may object to the sharing of data on their charging behaviour for privacy purposes. Approximately 40% of users that download the Ev Dot Energy app do not choose to share their data, and only use the core ev.energy service of tracking charging at home.
IMPLEMENTED MGT PRACTICES	<p>The company is compliant with GDPR policies. They also offer their users the option to opt out of data sharing with their utility when they create an account with them, or to opt out later on in their Account Settings page.</p> <p>The company has a privacy policy available on their website that clearly outlines the type of data that the company collects as well as the data that they share with third parties and for which purposes.</p>
