Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Industries at Risk of Human Rights Violations

Topic	Forced labor and human rights violations are recognized as material issues in the cocoa industry.
Summary of Issue	As a plant-based chocolate producer and seller, Meurisse Chocolate operates in an industry in which human rights issues such as forced labor, child labor, and human trafficking are prevalent globally in the cocoa supply chain.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue is from the cocoa industry.
Impact on Stakeholders	The global cocoa industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
Implemented Management Practices	The company has the following practices in place to address the risks associated with the cocoa/chocolate supply chain: Meurisse is certified Organic and Fairtrade. 100% of the cocoa sourced are covered by these certifications. The company works with cocoa farmers via the Cacao Trace program to improve crop yields and quality, thereby helping to increase farmer incomes and improve family livelihoods. Cacao-Trace ensures that farmers receive the Chocolate Bonus, which is 10 Eurocents collected for every kg of Cacao-Trace chocolate sold and is paid 100% back to farmers.
