Topic	Clients in Controversial and Ineligible Industries
Summary of Issue	Abovo Media has clients in the following industries: Gambling and Charity Lotteries. The types of services/products offered to these clients include: - Digital marketing consultancy.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 3.73% of the company's annual revenue was from clients in Gambling, and 0.42% from Charity Lotteries.
Impact on Stakeholder(s)	Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. Companies offering certain types of services and products to controversial clients are required to have at minimum a grievance/complaints mechanism and a whistleblower protection policy.
Implemented Management Practices	Abovo Media has the following mechanisms in place to manage the risks associated to serving clients in the mining industry: Grievance/complaints mechanism. This is accessible to the public through the website contact form or whistleblower email vertrouwenspersoon@abovomaxlead.nl. The company aims to contact complainers within 2 business days after the grievance submission. Employees and internal stakeholders can also report misconduct and irregularities to their managers or to the integrity counselor. If Abovo Maxlead chooses not to investigate a complaint, Abovo Maxlead will inform the whistleblower of this decision and give the reasons for it. Whistleblower Protection Policy. The policy includes the

	following statements: • Confidentiality - Whistleblowers have the opportunity to report confidentially via a confidential integrity person. Their identity is only disclosed with their permission. • Protection against discrimination - The policy explicitly provides for a ban on discrimination, such as dismissal, change of position, or disciplinary measures, when a whistleblower reports in good faith. Measures are taken to prevent bullying, exclusion, or intimidation of whistleblowers. • Support and guidance - Confidential advisors offer shelter, guidance, and support to whistleblowers. They help assess whether a report is justified and advise on the steps to be taken. • Investigation procedure - A report is recorded, and a transparent investigation procedure is followed. Investigators work independently and impartially. The whistleblower is kept informed of the progress and outcome of the investigation. • Treatment investigation - If a whistleblower feels retaliated, an investigation can be requested to identify the type of retaliation being conducted.
