Issue Date	2023
Topic	Litigation cases filed against Blisce by NY State Department of Taxation and Finance
Summary of Issue	Blisce had unpaid warrants and was involved in debtor lawsuits in relation to unpaid invoices from the NY State Department of Taxation and Finance. The company claims that following the closing of the coworking office space they rented out prior to the COVID19 pandemic they incurred delays in receiving their mail and were unaware of the pending payments prior to litigation. The payment was made, even without prior knowledge of the litigation. The company affirms that they discovered this litigation during their BIA process.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	2 Warrants issued to the company were under \$50 in value in 2021 and 2022. Payments were due in relation to warrants - nothing linked to any litigation
Impact on Stakeholders	In addition to the many different aspects of value that businesses provide to society, businesses have an obligation to contribute their share of taxes. As businesses exist within the context of society; their proper role is to serve society. Moreover, healthy businesses can only exist over the long term in a healthy society. A healthy society depends upon public expenditures made possible by taxes. These public expenditures benefit business in both direct and indirect ways.
Resolution	The warrants have been paid and letters of satisfaction received.
Management Practices	The company has now moved to a new building, changed the legal address with all suppliers as well as official agencies in order to avoid similar litigation issues in the future.
Management Comments	As explained in previous comments, nothing to add really, we had never heard of this litigation before. We just paid the amount due when we realized we forgot. The litigation has never had any impact or else
