



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	13.09.2021
TOPIC	Voluntary product recall
SUMMARY OF ISSUE	The presence of Ethylene Oxide (EtO) in Fortifit Muscoli e Ossa Mirtilli rossi 7BST due to cross-contamination led to the recall of these products from the market and the stop of its production
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	No individuals were affected directly, but huge recalls from the market and production stop had financial implications for the company (batches MU383, MU384, MU385). 100% of the Consumers (retails, individuals, ...) were informed about the recall issue, while 63% of the products distributed (or not yet) were verified to be removed or destroyed completely.
IMPACT ON STAKEHOLDERS	S.I.I.T (Supplier of the product), Crisis Manager, Quality Director, Business Manager
RESOLUTION	"Remediation: Stop the production and stop the selling of the products. Voluntary recall: both retails and consumers were warned to perform a check and consequent recall of the batches identified. Refunds or substitution of the products were performed."
IMPLEMENTED MGT PRACTICES	Recalls, Refunds, Supplier was charged for the penalties and recalled the products quickly
