Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries.
Summary of Issue	Home offers an employee-led consulting service designing tailored experiences for clients to design a strategy, create and manage change and provide creative solutions. The company has had one client operating in the gambling industry over the last 5 years and has had clients operating in the Fossil Fuel, Pharmaceuticals, Alcohol, and Water Utilities industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The client in the gambling industry represented 3.61% of the company's revenue in 2020/2021. The company has stopped working with this client and has no plan to start again. Clients operating in the Fossil Fuel industry represented 8.44% of the company's revenue in 2021/2022. Clients operating in the Water Utilities industry represented 4.53% of the company's revenue in 2021/2022. The client operating in the Alcohol industry represented 1.06% of the company's revenue in 2021/2022. The company hasn't had clients in the Pharmaceutical Industry since 2020.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Home's policy is to research potential clients and talk as an internal team about their working practices before deciding to take on work with them. The company has developed a new process for screening new clients that involved:

	-Online research for news articles from reputable news outlets -Identify business owners and look into any other business links they have with unethical business practices or industries -Review organization's code of ethics and environmental policy - Review organization's external ethical and environmental standards/commitments. -All businesses filtered through the Business & Human rights Resource Center (link below). Home has turned down work from companies operating in controversial industries or that are involved in controversy.
