SUMMARY OF ISSUE	The company sources from forests that contain the Manuka tea tree.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	81% of their supplier spend is with beekeepers for honey
IMPACT ON STAKEHOLDERS	"Manukora has a supplier code of conduct (draft) that outlines what they expect from suppliers in regards to animal welfare. The beekeepers that they work with follow traditional beekeeping methods which means that:
	- Bees are minimally disturbed: The majority of their colonies are not shifted each year. Some are in extremely isolated locations with no winter pollen sources so they are transported into ""wintering"" sites during winter. These sites are a maximum of 200 miles from the harvest location, meaning they are not shifted across the country and are not disrupted for extended periods of time. Hives are only transported after dark so that all of the bees within the hive are kept together.
	- Bees are fed naturally and no chemicals/synthetics are used: Bees are fed natural honey during the winter months and only supplemented with non-GMO sugar syrup and proteins in regions of NZ where it is necessary for support of the health of the bees. Hives are placed away from agricultural activities such as sprays so that all honey complies with glyphosate residue free certification (Project Detox free) whilst no antibiotics are used on bees in NZ. The maximum number of hives in a set area of 1 per hectare of Manuka so no overstocking occurs and there are plentiful food sources.
	The company does not yet have a formal process by which they monitor animal welfare with their suppliers."
IMPLEMENTED MGT PRACTICES	"The company does not currently have a standard covering animal welfare or biodiversity impact but the company is currently working on a draft Maukora Standards (Supplier Code of Conduct) that will be distributed to suppliers in the coming months.
	The company does not have any targets on animal welfare of local biodiversity impact. "
