Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	The company has an office located within a natural park area covering a Holocene volcanic field in Catalonia, northeastern Spain
Summary of Issue	Parc Natural de la Zona Volcànica de la Garrotxa (PNZVG) is a natural park area covering a Holocene volcanic field in Catalonia, northeastern Spain. The volcanoes, of which there are about forty within the park, are no longer active. The area is protected by the Generalitat of Catalonia and regulated under Decree 41/2008 of February 26, which defines its boundaries, establishes partial nature reserves, and outlines the management of its territory.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	95.57% of the company's facilities, in terms of area, are located in a sensitive ecosystem.
Impact on Stakeholders	The company's office is located in a sensitive ecosystem, which could potentially impact the flora, fauna, and quality of the ecosystem.
Implemented Management Practices	Energy Tools Consulting maintains a strong commitment to sustainability and environmental management, applying internal environmental sustainability policies. The company's presence within the Natural Park of the Volcanic Zone of the Garrotxa is part of a responsible integration model with the environment, respecting environmental regulations and contributing to the preservation of the ecosystem without generating negative impacts on it. The company's location within the park was subjected to prior studies and approvals by the managing bodies of the PNZVG and the competent administrations. Additionally, any construction or activity within the park is subject to review by an architect specializing in environmental regulations and sustainability, who ensures that all interventions respect the ecosystem and established regulations.
