Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Veerless is a consulting firm specializing in topics related to Environmental, social, and governance (ESG), Sustainability, & Corporate Responsibility, Strategic Planning & Initiative Management and Navigating ESG Ratings, Rankings & Regulations. The company has had clients in the Breastmilk Substitutes (BMS) and Pharmaceutical industries which are deemed controversial by B Lab. The services offered to these clients relate to managing the outcomes and impact development process for its the client's flagship community impact program and impact measurement and outcomes development related to the client's Sustainability Plan and other community and corporate citizenship programs. Veerless has also developed the client's Corporate Responsibility Report and continues to work with clients to develop ESG Strategy and materiality study. The services provided to the client can be sold to other clients in different industries, including other non-controversial industries, although it is tailored from client to client.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated 3% of total revenue from clients in the BMS industry and 7% from clients in the pharmaceutical industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Veerless currently does not have a formal position on working with sensitive industries or a policy to move away from them.
