

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs after the conclusion of a large project for which extra staff had been hired.
SUMMARY OF ISSUE	Employees were terminated at the end of a large project. The employees had been hired for the duration of that project on a full time contract without an expected end. It was the first time that a project of this magnitude has been undertaken by the company and the employees were advised verabally during the hiring process that they would only be employed for the duration of the project.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	8 employees were laid off, representing 20.5% of the company's employees at that time.
IMPACT ON STAKEHOLDER(S)	The management does not know whether the 8 employees that were laid off were able to obtain subsequent employment.

IMPLEMENTED MGT PRACTICES	The company has not created any formal policy to date that deals with the hiring of full time staff for the duration of large projects.
