This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	March of 2020
TOPIC	Significant layoffs due to [Significant layoffs due to COVID-19 business impacts.]
SUMMARY OF ISSUE	Due to the unfortunate results of the Covid-19 pandemic, In March of 2020, Costco shut down all sampling demos. They applied for PPP but were denied, and as a result, they furloughed and eventually laid off their Roadshow support staff.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	1 round of lay-offs in March 2020 and 8 employees were laid-off, 50%
IMPACT ON STAKEHOLDERS	Their employees were without jobs, which was pains for them. They offered to rehire all team members 17 months later, promptly after Costco reinstated the Roadshow events. Inked Bread offered references and tapped their resources to try and find other job placements. They also provided one laid-off employee a loan, so they could acquire an apartment.
IMPLEMENTED MGT PRACTICES	Delphi is targeting their expertise and work at clients with net zero / science based climate targets. The company works with high GHG emitting clients only when their efforts to reduce environmental impacts are backed by targets, rigorous quantitative standards, strong governance, and public transparency. Delphi tracks the GHG reductions that are quantified by their projects, as well as the clean tech investment activity catalyzed by their work, and they track the investment and jobs that are defined / quantified in their green and circular economy work.
RELATED INCIDENTS (YES/NO)	These lay-offs were a result of the pandemic, they would not have happened otherwise.
