Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- 1) Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Topic	Litigation related to labor issues
Summary of Issue	Optel Group faced two litigation cases related to labor issues in the past 5 years, including disputes about overtime payment and unfair dismissal.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Among the matters faced by the company in the last five years, the following were considered material to B Lab:
	 A class action involving 26 parties disputing overtime payment, with a total value of US\$ 580,000.00; One litigation case related to unfair dismissal, with an associated value of CA\$ 269,028.65.
Impact on Stakeholders	The primary impact of litigation cases related to overtime payment and unfair dismissals is potential financial harm to the workers involved.
Resolution	The class action was settled with the involved parties and paid by the company. The litigation case related to unfair dismissal was ruled against the company and paid.
Management Practices	For the class action related to overtime payment, the company updated its management policy with guidelines on bank of hours and overtime. Regarding the litigation related to unfair dismissal, the company hired in-house counsels to prevent new issues.
