



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The Workmate group offers services to companies that operate in the mining industry (mining companies and their contractors), on an ongoing basis. On the one hand the group offers a temporary personnel management service for companies that have short term personnel needs and is a recruitment and selection company. On the other hand the group offers consulting and outsourcing of transversal services for large construction and operations projects. The services provided include: Inspection of regulatory fulfilment of clients (and their suppliers) in relation to labor practices and environmental standards and legislation of warehouses, supply chain management and the development and maintenance of process automation platforms.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The Workmate group is composed of two companies, 99% of Workmate S.A's revenue (derived from service of consulting and outsourcing of services) is from companies that operate in the mining industry. 26% of Workmate EST S.A's revenue (derived from temporary personnel management service) comes from clients that operate in the mining industry.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	The company's service aims to enable companies in the mining industry to comply with regulations and standards associated to labor requirements, health and safety and compliance with environmental standards related to ISO90001, 14001, and 45001. The company's service can be offered to any company with a high number of personnel and materials (eg.energy, construction). It is the company itself that carries out the services within the mining site. The company does not have a formal policy that declares their position on working with clients in sensitive industries, yet have declarations related to working with clients that comply with regulations and have ethical behavior.
