- 2) Describe how the company has addressed this issue.

SUMMARY OF ISSUE	At the start of 2019, AltSchool's executive team determined that, in order to extend our runway and provide ongoing support to the schools and communities that we serve, the company would need to significantly reduce costs and shift our focus from running schools to growing its network of partner schools and school districts. As a result, and over the following 7 months, 47 full-time positions were eliminated.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In total over the past year, 49 staff positions were eliminated. 47 in 2019, as a result of this reorganization, and 2 in late 2018, when AltSchool closed its NY engineering office.
IMPACT ON STAKEHOLDERS	Loss of employment for the staff impacted by the eliminated positions. All impacted employees were given significant combined notice and severance. Other support offered included a resume-writing workshop, job matching within our investor network, and premium membership with LinkedIn. AltSchool has a strong alumni network and believe that most, if not all, have secured jobs.
RESOLUTION	We have come out of a research and development phase with a clear view as to how to we can best achieve our vision. We intend to keep our staff focused and lean, and feel we are right-sized for the work ahead.
IMPLEMENTED MGT PRACTICES	Quarterly budget reviews and C-level approval of all new positions.
