Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Company sells cannabis based products
Summary of Issue	Hemp Heros is an Ireland based company which manufactures CBD and Hemp Products, such as pet products, balms and tea.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In 2022, 100% of the company's revenue was from sales of CBD and hemp-related products.
Impact on Stakeholders	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	All of their products comply with food law in both the EU and UK. Their products are registered food supplements with the Food safety Authority of Ireland. As Hemp Heros' products are cold pressed, they are compliant with Novel food regulation. In order to ensure constant compliance, all of all products are third-party lab tested to ensure they meet EFSA guidelines. The company is not involved in the sale of medicinal nor recreational marijuana products.
