



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The Nursery Research & Planning is a research marketing agency with clients in alcohol, gambling and fossil fuel industries. Their services include product development research projects; understanding the effectiveness of clients' marketing and brand communications activity and understanding competitive market structure.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Fossil Fuel Industry represents 2.7% of their total revenue for FY21. Gambling Industry represents 5.6% of their total revenue for FY21. Alcohol Industry represents 3.9% of their total revenue for FY21.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	The Nursery Research & Planning claims to comply with all of the regulations and laws related to their marketing activities in the jurisdictions in which they operate. The company also states to follow Market Research Society's Code of Conduct. The company also has a written client policy which allows the Board of Directors to determine industry sectors or specific clients which they are not prepared to work with. Beyond that, all employees have the right to decline to work on a particular client's business or in a particular industry sector. The Nursery also has a CSR policy in which they state: "We will not work with people or organisations who do not trade ethically. We consider ethical trading to include (without limitation) financial and legal probity, social welfare (such as equality and diversity, avoidance of child exploitation, human slavery etc), commitment to the minimum wage and fair employment, paying a fair price for goods and services, and the use of sustainable resources.
