Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Other - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Assembly APAC is a global marketing company which has ongoing clients classified as controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	During the last fiscal year the company earned 0.38% of revenue from the Gambling industry. The company no longer serves this client.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact on stakeholders of those businesses by enabling their business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. Currently, B Lab does not have specific requirements for companies with clients in this/these industries. However, Certified B Corps are required to make transparent their involvement with such clients. As B Lab continues to evolve its standards and due diligence approach for companies with Clients in Controversial Industries, the updated criteria will be shared with the company once they are finalized. B Lab recognizes that the company began its verification process prior to B Lab developing standards for Clients in Controversial Industries, and, therefore, the company will be required to meet the new standards by their next recertification.
Implemented Management Practices	The company conducts due diligence when reviewing new clients in the above industries to ensure their client does not have a negative impact in the industry. Assembly Group is guided by B Corp guidelines and is aware that they will need to meet additional requirements such as a revenue threshold Assembly APAC has a policy on working with clients in sensitive industries that includes conducting due diligence into all new clients and existing clients when repitching and/or contract renewal and client guidelines which state the cocompany's position towards certain sectors. ESG risks including

	environmental sustainability practices, human rights and labour practices, ethical business practices and any other risks that might impact their brand or reputation are reviewed by the Global Head of Impact who will present the information to the Global Leadership Team who will make a final decision on whether to engage with the client from that sector. The company is also committed to circulating an internal client disclosure report to show where their revenue comes from, how many B Corps they serve and how many clients have set net zero targets.
