Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

The services provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries, although its onboarding tools and and programs are tailored from client/industry to client/industry to fit their organizations and help new joiners to contribute to the purposes of these organizations.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated a total of 16.4% of revenue from clients in the whole-life insurance industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Yes! We Connect does not work with clients from Drugs, Tobacco, Gambling, Lotteries, Fossil Fuels and Mining industry. The company actively follows news and public sources about its clients and potential clients. They also go through the clients' annual reports.
